**An obligatory site visit will be organized and conducted by the Employer/Client officials on 19<sup>th</sup>/12/2017 at 9am, at Jabana II Thermal Power Plant in Kigali City.** The place of departure will be **EUCL HQ in Kigali**. After the visit, there shall be a short pre-bid meeting. Bidders or their designated representative are strongly encouraged to attend the site visit and the pre-bid meeting.

Well printed bids written in English language, properly bound and presented in four (4) copies one (1) of which is the original and three (3) copies, **must reach to the Procurement Secretariat of EUCL on first Floor/room G114, not later than 09<sup>th</sup>/01/2018 at 10:00 am, local time (Kigali-Rwanda)** accompanied by **only a Bank bid guarantee of USD 14,000** issued by only a reputable Bank. Late bids will be rejected and the bids sent electronically will not be accepted.

Bids will be opened in the presence of bidders or their representatives who choose to attend on the **09<sup>th</sup>/01/2018 at 10:30 am, local time (Kigali-Rwanda)**. The bids will remain valid for One Hundred and Twenty (120) days starting from the deadline of submission. The offers will be opened at EUCL Ltd conference room.

A company will be selected under the procedures described in the Bidding Document, in accordance with the REG/EUCL procurement procedure manual as updated to date.

The copies will be presented in an envelope mentioning the bidder's names, address and the reference number of the tender as marked with the word **"To be only opened in public session"**.
