- The Government of Rwanda *has received* financing from the World Bank toward the cost of the *Accelerating Sustainable and Clean Energy Transformation*, and intends to apply part of the proceeds toward payments under the contract for *Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Kayonza & Gatsibo districts*. "For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing."
- The *Energy Development Corporation Limited (EDCL)* now invites Proposals from the interested eligible Applicants for *Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Kayonza & Gatsibo districts (33 km from Kigali)*:

- Bidders must have successfully completed at least two (2) similar plant design supply and installation works done within the last ten (10) years of similar nature and complexity, each with a value of at least USD 11.6 Million.
 - Minimum average annual turnover of US\$ 17.4 million, calculated as total certified payments received for contracts in progress or completed, within the last five (5) years.
 - Additional qualification details are provided in the Bidding Documents/ bid datasheet.
- The procurement will be conducted through international competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" September 2023 ("Procurement Regulations") and is open to all eligible Proposers as defined in the Procurement Regulations.

- A single-stage, where two envelope RFP process will be used, and the Proposal will consist of (i) the Technical Part, without any reference to prices; and (ii) the Financial Part, as detailed in the RFP Document. The Technical and Financial Parts of the Proposals shall be submitted simultaneously in two separate sealed envelopes.
- The Proposal, both the Technical Part and the Financial Part, must be delivered to the address below on 11/08/2024 at 10:30am (local time). Electronic Procurement will not be permitted. Late Proposals will be rejected. The Technical Part of the Proposals will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend at the address below on 10/08/2024 at 11:00am (local time). The Financial Part shall remain unopened and will be held in safe custody of the Employer until the second public opening of the Financial Part, following the evaluation of the Technical Part of the Proposals.
- All Proposals must be accompanied by a "Proposal Security" of **290,000USD** or in convertible currency.
- The non-compulsory site visit is scheduled on 11/09/2024 and the meeting point is Kayonza, district Office at 11:00am.
- The pre-bid meeting shall take place online on 12/09/2024 (The link to be shared).
