Bids must be delivered to the address below before or not later than 10:00am local time on 11.../14.../2024. Electronic bidding will not be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Fifteen Million Rwandan Francs (Frw 15,000,000) or Eleven Thousand United State Dollars (USD 11,000) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids
- 5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at 10:30 am local time on the same day.
