This payment shall be made to Account N° 25044962001/RWF opened at I & M Bank and the account N° 00040-00691030-35 (USD) opened at Bank of Kigali (BK) with code IBAN: RW4000040006910303500. Bids must be delivered to the address below **before or not later than 10:00am local time** on 15./11./2024. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Fifteen Million Rwandan Francs (Frw 15,000,000) or Eleven Thousand United State Dollars (USD 11,000) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
