All bids shall be accompanied by a bid security of Ten Million Rwandan francs (Frw 10,000,000) or Seven Thousand Three Hundred Fifty United State Dollar (USD 7,350), issued by a reputable bank or other financial institutions. Bidders must submit the bid securities with a validity period of 150 days from the date of its issuance. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at 10:30 am local time on the same day.
