Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Ten Million Rwandan francs (Frw 10,000,000) or Seven Thousand Three Hundred Fifty United State Dollar (USD 7,350), issued by a reputable bank or other financial institutions. Bidders must submit the bid securities with a validity period of 150 days from the date of its issuance. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
5. Well printed bids, properly bound and presented in four copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than 07/11/2024 at **10:00 am**. Late bids will be rejected and returned unopened.
