Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
4. All bids shall be accompanied by a bid security of One Million Two Hundred Thousand Rwandan Francs (Frw 1,200,000) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
