Lot 3: Carpentry materials
Lot 4: Mechanical Workshop Materials
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Procurement User Manual of REG as updated to date.

Late bids will be rejected and returned unopened.

All bids shall be accompanied by a Bid Security of Four Million (**4,000,000 Frw**) Rwanda Francs for each lot (Lot 1 and Lot 2), Four Hundred Fifty Thousand (**450,000 Frw**) Rwanda Francs for Lot 3 and Eight hundred thousand (**800,000 Frw**) Rwandan Francs for Lot 4 issued by a reputable registered financial institution in Rwanda with the validity period of one hundred fifty (150) days from the opening date of bids.
8. The bids will remain valid for **120 days** starting from the deadline of bids submission.
