This payment shall be made to Account 25044962001 opened at **I&M Bank**, Rwanda.
4. All bids shall be accompanied by a Bid Security of **Five Hundred Thousand Rwandan Francs (500,000 Frw)** issued by a reputable financial institution recognized in Rwanda with the validity period of **One Hundred Fifty (150) days** from the opening date of bids.

Well printed bids, properly bound and presented in two copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than **03/10/2024 at 10:00 am**. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
